Material Composition

Printed or unprinted Brown/brown paperboard with seaweed extract based liner.

Intended use

The final product is suitable for **single use food contact with dry moist and fatty foodstuff at room temperature of lower**, which are not followed by long-term room temperature or refrigerated storage. Short term contact with **acidic foodstuff** (salade dressing, tomato sauces, etc) does not belong to intended use application.

Overall migration

The compliance with the intended use food contact applications has been confirmed by laboratory tests, performed by an (ISO 17025) accredited laboratory.

Specific Migration Limits (SML)

Specific Migration of Heavy Metals has been accessed according to method BS EN 645:1994. For each metal the samples tested complied with the requirements of the BfR Recommendation XXXVI for the present of toxic heavy metals.

Phtalates & Bisphenol A

Phtalates (DBP / BBP / DEHP / DIBP were not detected. Bisphenol A content has been assessed and was not detected

PFAS

Based on the statements or specifications of our raw material producers, we declare that no per- and polyfluoroalkyl substances (PFAS) has been used for the production or intentionally added during the production processes of above listed articles. These articles, therefore can be considered <u>free from intentionally added PFAS content</u>.

PFAS, is a group of more than 4 700 chemicals, are known to be highly persistent in the environment and have been frequently observed to contaminate groundwater, surface water and soil. Secondary contamination by per- and polyfluoroalkyl substances has not been assessed when preparing this declaration.

GMO

Based on the coating specification of our raw material producers, we declare that the components of the coating are derived from naturally occurring plant or mineral sources. They are not genetically modified and therefore no GMO-derived raw materials are used in the manufacturing process.
